- Depart from Main Lodge around 12:30pm.

# **Cancellations:**

- Refunds will only be issued once a replacement has been identified and paid in full for the trip. No refund will be issued if a replacement is not found. Refunds are subject to a \$50 fee.
- Replacements can be chosen from the waiting list. In the event there is no one on the QC trip waiting list, or waitlisted persons are no longer willing/able to go on the trip, the person requesting to cancel must find their own replacement. The replacement must be a Qualcomm Ski and Snowboard club member (or a family/friend of a member attending the trip) or a member of one of our affiliated ski club groups. The replaced must also be approved by the QC Ski Club board.
- Note the QC ski club board members and trip leaders are all volunteers. Their time/assistance in finding replacements is not guaranteed. The cancelling party has ultimate responsibility to find a replacement and assure they complete the registration and payment.
- Any trip cancellation policies enforced by the tour operators or vendors that QC Ski and Snowboard club uses will take precedence over the cancellation policy stated in this document.

#### **Accommodations:**

- Condo units and bedding assignments are decided on first-come-first-reserved basis.
  Bedding varies from unit to unit and consists of bunks, singles, doubles, queens and sofa hide-a-beds. First priority goes to couples. However, some couples may have to sleep on living room hide-a-beds or bunk beds if all others have been reserved first. Singles may be assigned to share.
- The trip cost covers accommodation and charter bus rides (SD-Mammoth round trip and daily rides to the mountain). Please note that the ski lift tickets as well as any items of a personal nature such as laundry, telephone bills, meals, ski rental, etc. is NOT included.
- Kids pricing is the same as adults.
